I spoke with you last month about reviving Architron Systems Inc., a Florida corporation (the "Company"). According to information on the Division's web site, the Company was suspended on September 22, 2000 for failure to file its 2000 annual report. However, after speaking to you, I understand that the Annual Report was actually filed and a check in the amount of \$150.00 was cashed by the Division on June 9, 2000. The Company received no subsequent communication from the Division indicating that its filing was deficient, and only learned of its suspension by going on the "sunbiz" web site. Because it appears that the 2000 Annual Report may have been filed after the May 1, 2000 deadline, a delinquency fee of \$300 may apply. Accordingly, I am enclosing the following documents to have the Company reinstated:

- 1. Corporation Reinstatement Form;
- 2. Check in the amount of \$300 to cover the delinquency fee;
- 3. Statement of Change of Registered Office or Registered Agent or Both for Corporations; and
- 4. Check in the amount of \$35 to cover the filing fee for the change of registered agent.
