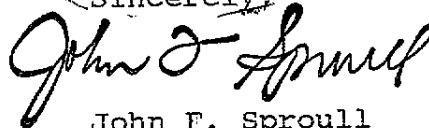

ARTICLE I - NAME

The name of the Corporation shall be R.R. SCOTT LATHING CO., INC.

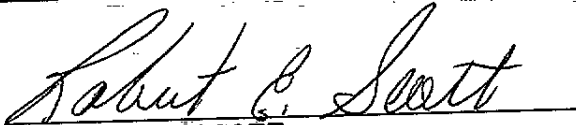

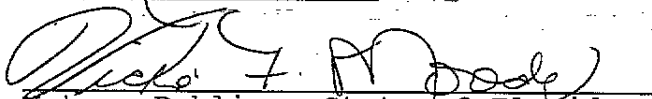

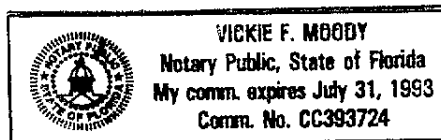
