ARTICLE I

NAME

The name of the corporation is **Causeway T&T Inc.**

ARTICLE II

DURATION

This corporation shall commence as of the date hereon and shall exist
perpetually thereafter until desolved according to law.

ARTICLE III

NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the
laws of the United States and of the State of Florida.

ARTICLE IV

CAPITOL STRUCTURE

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100,000 of common stock, having a par value of \$1.00 per share

ARTICLE V

PREEMPTIVE RIGHTS

Every share holder, upon the sale for cash of any new stock of the Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI

INITIAL REGISTERED AGENT AND REGISTERED OFFICE
