

ARTICLES OF INCORPORATION OF HULL WELL & PUMP SERVICE, INC.



THE UNDERSIGNED, acting as sole incorporator of HULL WELL & PUMP SERVICE, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I
