# A.C.E. PROPERTY MANAGEMENT OF ORLANDO, INC. (a Florida Corporation)

The undersigned for the purpose of forming a Profit Corporation pursuant to the Florida General Corporation Act, Chapter 607, Florida Statutes, as amended, hereby adopt the following Articles of Incorporation:
