ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of this corporation shall be REX RESOURCES CORPORATION, INC., and its principal address is 3915 Headsail Drive, New Port Richey, Florida 34652.

ARTICLE II

This corporation shall have perpetual existence which shall commence at the time of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III
