ARTICLES OF INCORPORATION

The name of the corporation is Pita's International, Inc.

ARTICLE TWO

The period of its duration is perpetual. The effective date of the corporation is March 9, 1998.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
