The undersigned, being of legal age, natural persons and duly licensed to practice dentistry under the laws of the State of Florida, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of incorporating a professional corporation under the laws of the State of Florida.

ARTICLE I
NAME AND ADDRESS

ARTICLE II
PURPOSE

No shareholder shall have preemptive rights, unless the stockholders otherwise agree.
