The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is POWERSPORTS OF FORT MYERS, INC. and its principal office and mailing address is 215 Fifth Street, Suite 108, West Palm Beach, Florida 33401.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on March 11, 1998.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV

Capital Stock

The aggregate number of shares of stock authorized to be issued by this corporation shall be 7,500 shares of common stock, each with a par value of \$.001. By-Laws

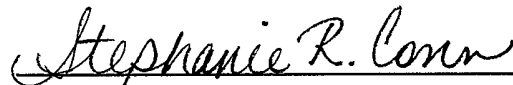
