1. On or about March 12, 1998 the Florida Associated Businesses, Inc., ("hereinafter FAB"), was established by filing the Articles of Incorporation with the State of Florida Secretary of State.
2. On or about September 24, 1998, the officers and directors of FAB, Inc., either in writing or by telephone submitted their resignation from the corporation.
3. No shares of stock prior to or following the Articles of Incorporation and the proposal to dissolve the corporation have been issued. Therefore, there are no shareholders of records in which to vote.
4. The directors of the corporation via telephone conference on or about September 25, 1998, voted to dissolve FAB, Inc. The number of votes casted for dissolution was sufficient for approval.
5. The corporation is therefore dissolved effective September 25, 1998.
