### ARTICLES OF INCORPORATION OF TRADING AGENCY EXPORT, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such a corporation:

#### ARTICLE I Name

The name of the corporation shall be Trading Agency Export, Inc.

ARTICLE II
Duration

The corporation shall have perpetual existence.
