ARTICLE I. -CORPORATE NAME

The name of this corporation shall be Northgate Enterprises, Inc.

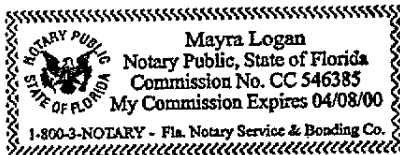
