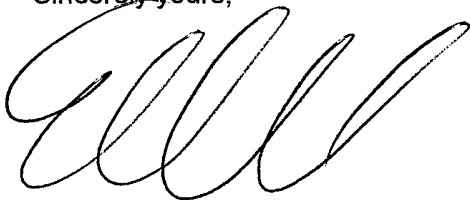

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I -- NAME

The name of the corporation shall be **GOAL LINE, INC.**

1. The general nature of the business of the corporation shall be operating a sports bar and grill and entertainment complex and any other lawful business.
