#### ARTICLES OF INCORPORATION

OF

#### SARAH'S PLACE, INC.

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

#### ARTICLE I. NAME.

The name of this corporation shall be named and known as SARAH'S PLACE, INC.
