#### ARTICLES OF INCORPORATION

OF

CAROL ANN GRIFFIN, P.A.

## ARTICLE I NAME:

The name of this Personal Service Corporation is: CAROL ANN GRIFFIN, P.A., hereinafter referred to as the "Corporation".

#### ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing on March 16, 1998.
