Amendment to Articles



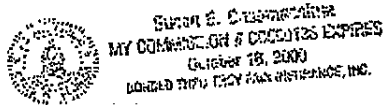
