## ARTICLES OF INCORPORATION OF PAWS & CLAWS PET DAYCARE, INC.

FILED 98 MAR 13 AM II: 12

The undersigned, acting as sole incorporator of PAWS & CLAWSARETSEE, FLORIDA DAYCARE, INC. (hereinafter, the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA") hereby adopts the following Articles of Incorporation (the "Articles") for the Corporation:

#### ARTICLE I Name

The name of the Corporation is: PAWS & CLAWS PET DAYCARE, INC.

### ARTICLE II Business and Activities

The Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.
