The undersigned Incorporator to these Articles of Incorporation, natural person, competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I. CORPORATE NAME

The name of this corporation shall be Energy Trading and Delivery, Inc.
The Principal office and mailing address shall be 4403 7th Street East, #1, Ellenton, Florida 34222.

ARTICLE II. PURPOSE, NATURE OF BUSINESS AND POWERS

The purpose of the corporation is to trade electricity, coal, gas, oil, and propane for cash and futures. The general nature of the business to be transacted and carried on by the corporation is to engage in any lawful act and activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III. CAPITAL STOCK

The total authorized capital stock of the corporation shall be 10,000 shares of common stock having a nominal or par value of \$.01 per share.

ARTICLE IV. TERMS OF EXISTENCE

This corporation shall have perpetual existence, commencing upon the filing of these Articles.

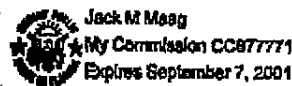
