ARTICLES OF INCORPORATION
OF

The undersigned for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT hereby adopts the following articles of incorporation.

ARTICLE ONE

The name of the corporation is BENGALAS INTERNATIONAL GROUP, INC.

The term of existence of the corporation is perpetual.

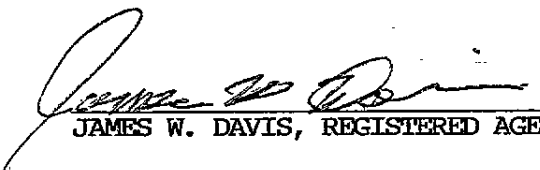
