Articles of Incorporation of M. D. Bridal Boutique & Florist, Inc.

The undersigned, acting as incorporator of M.D. Bridal Boutique & Florist, Inc. under the Florida Business Corporation Act, adopts the following articles of incorporation.

Article I -- Name

The name of the corporation shall be M.D. Bridal Boutique & Florist, Inc.

Article II -- Address

The mailing address of the corporation will be 2031 N.E. 163rd Street, North Miami Beach, Florida 33162. A second location will be at 625 N.E. 125th Street, N. Miami Florida 33161.

Article III -- Commencement of Existence

The existence of the corporation will commence on March 10, 1998.
