# ONE CLASS OF STOCK

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I

The name of the corporation shall be MOUNT ZION RELIGIOUS STORE, INC.

## ARTICLE II

The principal place of business and mailing address of this corporation shall be:

#### ARTICLE III

The aggregate number of shares that the corporation shall have authority to issue and to have outstanding at any one time is One Hundred (100) shares. All such shares shall be of a single class, designated as common.

Each holder of common shares shall have one vote for each such shares held on record on all matters submitted for shareholder approval.
