

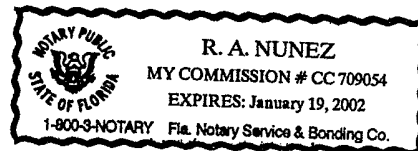


DESIGNATION AND ACCEPTANCE OF
