ARTICLES OF INCORPORATION

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, pursuant to Chapters 607 & 621, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is GEORGE DUTKEWYCH, M.D., P.A.

ARTICLE II: PURPOSE

The purposes for which it is formed are as follows:

(i) To practice, through individuals authorized by law, the profession of medicine.

(ii) To own real or personal property necessary for the rendering of the professional services which the Corporation is authorized to perform and to invest its funds in real estate, mortgages, stocks, bonds or other types of investments.

(iii) In furtherance of its corporate business, the Corporation shall have authority to pay pensions, establish and carry out pension, profit sharing, share bonus, share purchase, share option, savings, thrift and other retirement, incentive and benefit plans, trusts and provisions for any or all of its directors, officers and employees, and to exercise all of the powers conferred by the Florida General Corporation Act upon corporations formed thereunder, subject to any limitations contained in said law or in accordance with the provisions of any other statute of the State of Florida.

ARTICLE III: PLACE OF BUSINESS

The principal place of business of this corporation shall be:

1004 S. Old Dixie Highway, Suite 301  
Jupiter, Florida 33458

ARTICLE IV: CAPITAL STOCK

The total number of shares of capital stock authorized to be issued by the Corporation will be two hundred (200) shares having no par value per share. Each of the said shares of stock will entitle the holder thereof to one (1) vote at any meeting of the stockholders.

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

The initial registered agent for this Corporation is GEORGE DUTKEWYCH and the initial registered office is located at 1004 S. Old Dixie Highway, Suite 301, Jupiter, Florida 33458. The Board of Directors may, from time to time, move the principal office to any other address.

ARTICLE VI: INITIAL BOARD OF DIRECTORS

The Corporation will have one (1) director initially. The number of the directors may be either increased or diminished from time to time by the by-laws. The name and address of each person who shall serve as a member of the initial Board of Directors is:

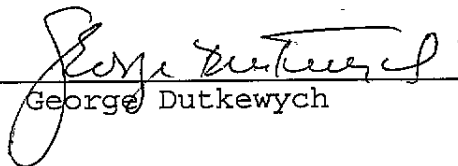
ARTICLE VIII: AMENDMENTS
