TO THE ARTICLES OF INCORPORATION

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, **UCHE AND SAMPONG, P.A.**, adopts the following Articles of Amendment to its Articles of Incorporation:
