The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME AND PRINCIPAL OFFICE OF CORPORATION

Citrus Park Investments, Inc. shall be the name of this corporation, and the mailing address and its principal office shall be: 4930 Sandpiper Lane South, St. Petersburg, Florida 33711.

ARTICLE II - NATURE OF BUSINESS


