1. My name is Robley M. Miles Jr., I am over the age of eighteen (18) years, and I have personal knowledge of the matters and things set forth in this affidavit.

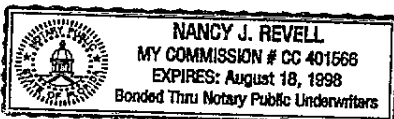
