## ARTICLES OF INCORPORATION OF

## C & S PAOLO CALIARI & PAOLA D. SMITH, INC.

The undersigned, for the purpose of forming a corporation under the Forida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. NAME. The name of the corporation is: C & S PAOLO CALIARI & PAOLA D. SMITH, INC.
