A PROFESSIONAL CORPORATION

The undersigned, who is a duly licensed to practice law in the state of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Corporations Act, adopts the following Articles of Incorporation.

FIRST: The corporate name for the corporation (hereinafter called the "Corporation") is Vincent O'Brien, P.A..

No shareholder, notwithstanding that he or she may have voted against the amendment or may have objected in writing, shall be entitled to payment of the fair cash value of his or her shares or any other rights of a dissenting shareholder.
