**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of D P MEDIA LICENSE OF LITTLE ROCK, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:


ARTICLE IX. BYLAWS


ARTICLE X. AMENDMENTS


