The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The qualifications for officers and directors and the manner of their admission are to be regulated as set forth in the By-Laws of the Corporation. The initial officers and directors shall be:

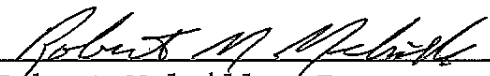

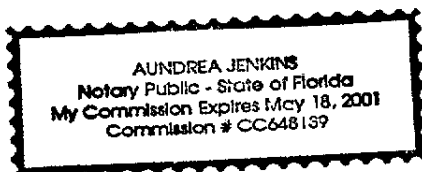

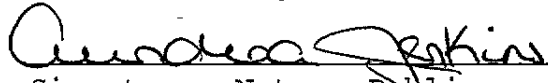
