The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation (hereinafter referred to as the "Corporation"), pursuant to the provisions of the Florida Business Corporation Act.

**Article I:** The name of the Corporation shall be Homecare America Supply Company of Orlando, Inc.

**Article II:** The principal place of business and mailing address of the Corporation shall be Homecare America, Renaissance Centre, State Road 436, Altamonte Springs, Florida 32714.

**Article III:** The number of shares that the Corporation is authorized to issue is 100 shares, all of which are without par value and are of the same class and are Common shares.

**Article IV:** The street address of the initial registered office of the Corporation in the State of Florida and the name of its initial registered agent at this office is National Registered Agents, Inc., 526 E. Park Avenue, Tallahassee, Florida 32301.

**Article V:** The name and the street address of the incorporator to these Articles of Incorporation is:

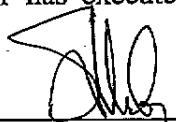
**Article VI:** The purpose for which the Corporation is organized, which shall include the authority of the Corporation, shall be to engage in any lawful business for which corporations may be organized under the Florida Business Corporation Act and to have all of the general powers granted to corporations organized under the Florida Business Corporation Act, whether granted by specific statutory authority or by construction of law.

**Article VII:** The duration of the Corporation shall be perpetual.

**Article VIII:** The Corporation shall, to the fullest extent permitted by the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, indemnify and hold harmless any and all persons whom it shall have power to


indemnify under said provisions from and against any and all liabilities (including expenses) imposed upon or reasonably incurred by him in connection with any action, suit or other proceeding in which he may be involved or with which he may be threatened, or other matters referred to in or covered by said provisions both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director or officer of the Corporation. Such indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, Agreement or Resolution adopted by the shareholders entitled to vote thereon or disinterested directors.
