The undersigned who is duly licensed to practice law in the State of Florida for purposes of forming a professional corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation shall be J. MICHAEL MATTHEWS, P.A.

**ARTICLE II  
DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III  
PURPOSE**

The purpose of the corporation shall be to engage in and carry on all branches of the practice of law within the State of Florida, and to do those things which are necessary or proper in connection with that practice.

**ARTICLE IV  
CAPITAL STOCK**

The aggregate number of shares which the corporation has authority to issue is one thousand (1000) shares, all of which shall be common shares with a par value of one dollar (\$1.00).

**ARTICLE V  
REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the initial registered office of the corporation is 201 South Orange

**ARTICLE VI  
PRINCIPAL PLACE OF BUSINESS**


