**ARTICLES OF INCORPORATION
OF
ITACOM INTERNATIONAL CORPORATION**

Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

ARTICLE ONE

The name of the Corporation is ITACOM INTERNATIONAL CORPORATION (the "Corporation").

ARTICLE TWO

This corporation shall have perpetual existence, and its corporate existence shall commence at the time of the filing of the Articles of Incorporation by the Department of State.

ARTICLE THREE

The Corporation shall engage in any activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE FOUR

The aggregate number of shares which this corporation shall have authority to issue is 100 shares of Common Stock, par value ten dollars (\$10) per share.

ARTICLE FIVE

The street address of the initial Registered office of the corporation in the State of Florida is 1221 Brickell Avenue, Suite 1660, Miami, Florida 33131 and the name of the registered agent of this corporation at that address is Jorge Luis Schcolnik. The power to adopt, alter amend or repeal bylaws shall be vested in the Board of Directors and the shareholders.


ARTICLE NINE
