ARTICLE I

NAME

The name of the corporation is D. W. MILLER CONSULTING GROUP, INC. The address of the principal office of the corporation is 523 North Halifax Avenue, Daytona Beach, Florida 32118, and the mailing address of the corporation shall be the same.

ARTICLE II

DURATION

The duration of the corporation is perpetual. ARTICLE III



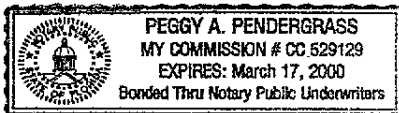
