In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is TrueNet Systems, Inc.

ARTICLE II

The existence of the corporation shall begin on March 18, 1998.

ARTICLE III

The street address of the principal office of the Corporation is 4431 Withrowwood Circle, Orlando, FL 32837.
