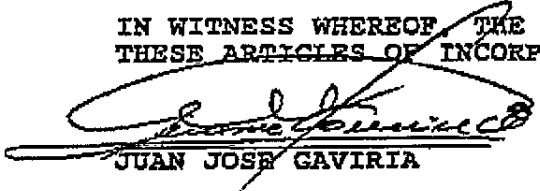
AMENDMENT
