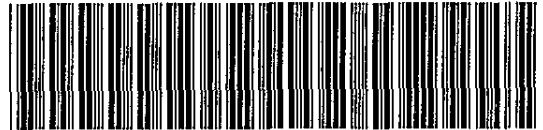

Pursuant to the provisions of Section 607.1006 of the *Florida Statutes*, Access Transport Services, Inc., a corporation organized and existing under the laws of the State of Florida, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Section 1 - Name

The name of the corporation is Access Transport Services, Inc. (hereinafter referred to as the "Corporation").
