Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

1. The name of the corporation is AAAAAAAAAAAAAAAAAAAAAAAAAAAAAAAAAAAAAA

2. The principal office of the Corporation is:

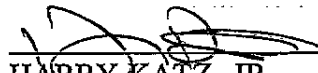
