In reviewing the notice, I noticed that if I had filed the 1998 Profit Corporation Annual Report by May 1, 1998 the filing fee would have been \$150. I am writing this letter to because of my inexperience with the State of Florida operating procedures.

I incorporated Mason's Auto Paint & Collision, Inc. on 03/16/1998. I did not file the Profit Corporation Annual Report in 1998. In 1999, I continued to operate the business unaware of the Profit Corporation Annual Report filing requirements until I received the 2nd Notice 1998 Profit Corporation Annual Report on 7/25/99. This 2nd Notice was the first notice that I ever received from the Division of Corporations. Inever received any notices at an earlier time. As soon as I received the 2nd Notice, I researched the notice and its filing requirements. I only then learned of the rules of compliance. So, now I'm making an earnest effort to properly comply with the filing requirements.

Since 1998 was the first full year of my corporation, I believe my actions demonstrated that I exercised ordinary care and prudence. My first year of incorporation has been a struggle.
