The undersigned, acting as incorporator, signs the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I

INC.

The name of this corporation is: **R.M. BARBEE & CO.,** (hereinafter the "Corporation").

ARTICLE II

This Corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III

**ARTICLE X**

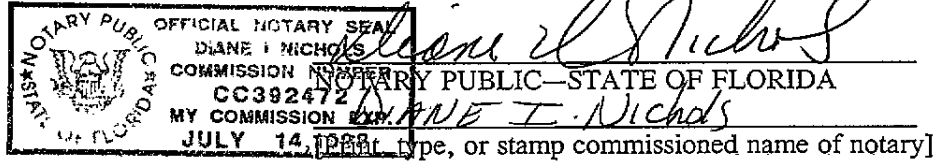
