ARTICLES OF INCORPORATION

OF

ARTICLE I. - NAME

The name of the corporation is A&A WISHENGRAD, INC. (hereinafter called the "Corporation").

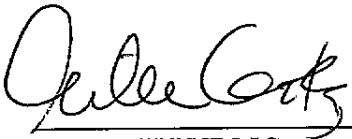

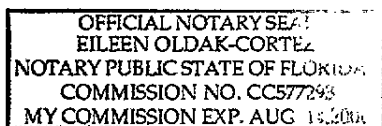

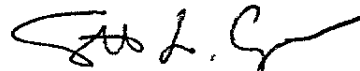
