STOCK RESTRICTIONS:

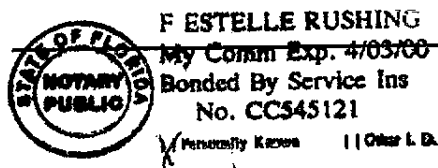
