ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is MANASOTA UNDERWRITERS, INC., and the principal address is:

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is: 8466 North Lockwood Ridge Road, Suite #250, Sarasota, Florida 34243. in the city of Sarasota, county of Sarasota. The name of its registered agent at such address is Daniel R. Russell.

ARTICLE III - PURPOSE
