

ARTICLES OF INCORPORATION

The undersigned, being an individual, does hereby act as Incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act.

FIRST: The corporate name for the Professional Service Corporation organized hereby (hereinafter called the "Corporation") is Thomas J. Fix, M.D., P.A.

SECOND: The street address of the principal office of the Corporation and the mailing address is 4118 Dakota Place, Palm Beach Gardens, FL 33418.

<u>THIRD</u>: The number of shares that the Corporation is authorized to issue is 1,000, par value \$0.01 each, are of the same class and are common shares.

FOURTH: The street address of the initial registered office of the Corporation in the State of Florida is 4118 Dakota Place, Palm Beach Gardens, FL 33418.

The name of the initial registered agent of the Corporation at the said registered office is Thomas J. Fix, M.D.

The written acceptance of the said initial registered agent, as required by the provisions of Section 607.0501(3) of the Florida Business Corporation Act, is set forth following the signature of the incorporator and is made a part of these Articles of Incorporation.

SEVENTH: The purposes for which the Corporation is organized, which shall include the authority of the Corporation to engage in any lawful business for which corporations may be organized under the Florida Business Corporation Act, are as follows: the provision of the personal services rendered by physicians and surgeons and doctors of medicine and any and all services and activities related thereto or necessary, appropriate or desirable in the rendition thereof, and, in addition, investing funds in real estate, mortgages, stocks, bonds or any other type of investments and owning real or personal property necessary or desirable for the rendering of such professional services.

EIGHTH: The duration of the Corporation shall be perpetual.

PIMAIN01: 122205_1.WPD Printed: 03/03/98 10:15AM NINTH: The Corporation shall, to the fullest extent permitted by the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any By-law, vote of shareholders or disinterested directors, or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.
