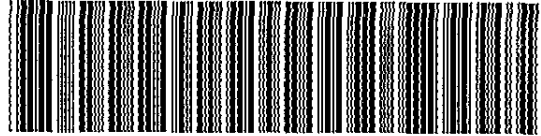

Effective November 1, 2003, the current Article I was deleted in its entirety, and the following substituted in its place:




CORPORATE NAME
