ARTICLE I. CORPORATE NAME

The name of this corporation is: GULFSTREAM PROFESSIONAL SERVICES; -Inc.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in the business of management services and other related activities, and other contractual related services, along with any and all other business permitted under the laws of the United States of America and the great state of Florida.
