Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, PARK CENTRAL PROPERTY MANAGEMENT, INC. adopts the following Articles of Amendment to its Articles of Incorporation:


1. The name of the corporation is PARK CENTRAL PROPERTY MANAGEMENT, INC.
2. The original Articles of Incorporation for the corporation were filed on March 19, 1998, and assigned Charter No. P98000026002.
3. By written consent executed on May 12, 1999 by the sole Shareholder and Directors of the corporation, respectively, the sole Shareholder and Directors have approved, authorized and directed that the Articles of Incorporation shall be amended to change the name of the Corporation to "ELKAR MANAGEMENT CORP.". The amendment was approved by the sole Shareholder and the number of votes cast for approval was sufficient.
4. Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I - NAME

The name of this corporation shall be ELKAR MANAGEMENT CORP.
