Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, ELKAR MANAGEMENT CORP., adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is ELKAR MANAGEMENT CORP.
2. The original Articles of Incorporation for the corporation were filed on March 19, 1998, and assigned Charter No. P98000026002.
3. An Amendment to the Articles of Incorporation for the corporation was filed with the Florida Department of State on May 17, 1999.
3. By written consent executed on June 30, 1999 by the sole Shareholder and Directors of the corporation, respectively, the sole Shareholder and Directors have approved, authorized and directed that the Articles of Incorporation shall be amended to change the name of the Corporation to "PARK CENTRAL MANAGEMENT, INC.". The amendment was approved by the sole Shareholder and the number of votes cast for approval was sufficient.

4. Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I - NAME

The name of this corporation shall be PARK CENTRAL MANAGEMENT, INC.
