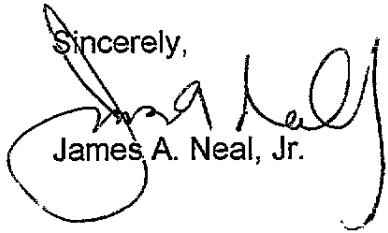

**Article 11. Pre-emptive Rights.**

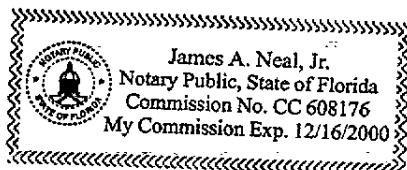
