ARTICLES OF INCORPORATION

The undersigned incorporator, being a natural person competent to contract, subscribes to these Articles of Incorporation to form a corporation under the laws of the State of Florida.

I. NAME

The name of this corporation is Le Restaurant, Inc. and its principle place of business is 9539 Wickham Way, Orlando, Florida 32836.

II. PURPOSE

The purpose for which the corporation is organized is to engage in the retail sale of food and any other lawful purpose.

III. DURATION

The term of existence of the corporation is perpetual.

IV. CAPITAL STOCK

The number of shares of stock that the corporation is authorized to have outstanding is 200, all of which shall be common shares with par value of \$.01.

V. REGISTERED OFFICE

Every amendment shall be approved by the Board of Directors, proposed by them to the shareholders, and approved at a shareholders meeting by a majority of the stock issued and entitled to be voted, unless all the Directors and all the shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.


ARTICLE X. By-Laws

ARTICLES XI. Preemptive Rights



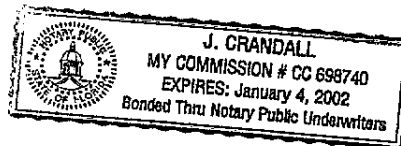
